Services and Fee Schedule

We specialize in providing supervised visitations at our office located at 907 N Main Lone Star, Texas. Our office provides a safe place for families to spend time together in a home-like, comfortable setting. Our location provides, comfortable seating, a living room, play room, kitchenette, outside play area, television, movies, games, and toys.

Intake- An intake meeting will occur with both parents (parties) before the time of the first visitation of any kind. During the intake meetings information will be gathered and forms will be filled out. A \$50 fee will be due from both parties before their respective meetings.

Phone Monitoring- A Visitation Specialist will connect calls between the non-custodial parent and the child. The Visitation Specialist will remain on the call throughout its entirety and ensure appropriateness and will end the call.

Monitored Exchanges at our Location- During a Monitored Exchange we provide a safe environment for parents to perform exchanges of the child(children) without having to come into contact with one another.

Monitored Exchanges Mobile- A Visitation Specialist will travel to your location and meet the parent with the children and supervise the exchange when the other parent arrives to pick up the children. The Visitation Specialist will stay until the exchange is completed and both parents have left the location.

Supervised Visitation at our Location- We specialize in providing supervised visitations at our office located at 907 N Main Lone Star, Texas. Our office provides a safe place for families to spend time together in a home-like, comfortable setting. Our location provides, comfortable seating, a living room, play room, kitchenette, outside play area, television, movies, games, and toys.

Supervised Visitation Mobile- A Visitation Specialist will travel to your location and meet the parent with the children and await the arrival of the visiting parent. The Visitation Specialist will monitor the entirety of the visit, assure appropriateness, and compose a report of the visit. The Visitation Specialist will leave only after both parents have left the premises.

Therapeutic Supervision Intake- An intake will occur with both parents (parties) before the time of the first visitation of any kind. During the intake meetings information will be gathered and forms will be filled out. The therapeutic sessions may be covered by insurance.

Therapeutic Sessions- These sessions will include therapeutic counseling with the visit. The therapeutic session is advised for high-conflict families who are at risk for domestic violence, physical or verbal abuse, and parents with a history of very poor parenting skills require the use of therapeutic supervised visitation programs. Those who have previous allegations of sexual abuse, who have threatened to abscond with the child, or with a history of severe parental alienation are also generally good candidates for therapeutically supervised visitation. By having a mental health professional supervise visitations, our staff is able to assist in identifying and attempting to correct any issues that may prevent the parent from having a healthy and productive relationship with their child. These sessions may be covered by insurance.
